PGY1 Pharmacy Residency Program

Pharmacists at Baptist Health Medical Center - North Little Rock work with the healthcare team to ensure positive patient outcomes. Services provided by pharmacists span beyond decentralized clinical consultation (dosing - pharmacokinetic, antimicrobials, anticoagulation; antimicrobial stewardship - culture review, de-escalation; IV to PO; nutrition support; electrolyte replacement; etc.) to include Graduate Medical Education integration, multidisciplinary rounds, and transitions of care.

Learning Opportunities

- Engage with other healthcare professionals on multidisciplinary rounds – intensive care unit, rehab, and family medicine teams
- Obtain BLS & ACLS certifications and participate in the management of medical emergencies
- Participate in the teaching & research certificate programs through the University of Arkansas for Medical Sciences College of Pharmacy
- Serve as a preceptor for APPE students
- Provide continuing education for pharmacists and other healthcare professionals
- Participate in P&T Committee meetings
- Complete a research project and present at a regional residency conference
- Lead journal clubs, patient cases, and topic discussions for pharmacy students
- Provide clinical staffing one evening per week and every fourth weekend
- Serve at a charitable clinic monthly

Purpose

PGY1 pharmacy residency programs build on Doctor of Pharmacy (PharmD) education and outcomes to contribute to the development of clinical pharmacists responsible for medication related care of patients with a wide range of conditions, eligible for board certification, and eligible for postgraduate year two (PGY2) pharmacy residency training.

Eligibility

- Graduate or candidate for graduation from an ACPE accredited Doctor of Pharmacy degree program Arkansas Licensure by July 31st
- Successful completion of a required pre-employment screening

Application Process

Candidates must submit their application through PhORCAS by January 1st and include the following:

- · Online application form
- Letter of intent
- Curriculum vitae
- · Three letters of recommendation
- Official transcript
